Notice of Acquisition of Shares of Kyokuto Electric Co., Ltd. (Conversion into a Subsidiary)

Kaga Electronics Co., Ltd. (President & COO: Ryoichi Kado; headquarters: Chiyoda-ku, Tokyo; hereafter "the Company"), as announced in the press release "Basic agreement concerning sponsorship of civil rehabilitation of Kyokuto Electric Co., Ltd." dated August 31, 2020, hereby announces that it has acquired 100% of the shares of Kyokuto Electric Co., Ltd. (Representative Director: Yasuhiro Sawada; headquarters: Osaka; hereinafter "Kyokuto Electric"), which was established through a corporate split on November 2, 2020, and made it a consolidated subsidiary of the Company.

By leveraging the competitiveness of the EMS business, the Company aims to become the leading company in the industry in Japan by achieving the 500-billion-yen level of sales envisioned in the Medium-Term Management Plan. Furthermore, the Company will continue to expand the scale and improve the quality of the Group's management with the aim of becoming a company that can survive global competition with overseas companies with sales of trillion yen.
