1. About JPX-Nikkei Mid and Small Cap Index

The JPX-Nikkei Mid and Small Cap Index is an index that applies the concept of the JPX-Nikkei 400, which is an index comprising highly attractive listed companies, to mid and small cap equities by selecting companies that focus on capital efficiency and investor-oriented management. It aims to foster greater awareness of such issues among listed companies and to meet the needs of investors looking to invest in such companies.

When selecting the constituent stocks of the said index, consideration is given to the liquidity of each stock in the market to facilitate actual use of the new index for asset management.

2. Constituent selection method

The constituents are selected from among common stocks whose main market is the Prime Market, the Standard Market, or the Growth Market of the Tokyo Stock Exchange through a screening process based on eligibility criteria, which include whether or not a deficit was recorded in the past three fiscal years, market capitalization, and market liquidity indicator, subsequent to which scoring of quantitative indicators (three-year average ROE and three-year cumulative operating profit) and additional scoring of qualitative factors (such as appointment of independent external directors and disclosure of earnings and other information in English) are conducted, to select the top 200 issues.
